2014 MOVING TOWARD OUR VISION



In 2012 the Kootenai

Health board completed a strategic planning process that included an updated vision for Kootenai Health to expand and enhance the health care services provided in northern Idaho. During 2014, Kootenai Health took several major steps toward that goal. From joining the Mayo Clinic

Care Network, to receiving verification as a Level III Trauma Center, to breaking ground on a needed expansion, Kootenai's vision became reality. Here are a few of the highlights from 2014, and a look at the good stewardship that's making it all possible for our community.

PATIENT-FOCUSED GROWTH

Heart Clinics Northwest in Post Falls (208) 625-5530

Kootenai's Heart Clinics Northwest cardiology practice opened a new location in Post Falls. The new location offers greater convenience for patients in Post Falls, that goes beyond just office visits. Because Heart Clinics Northwest offers the full spectrum of cardiac subspecialty care and has additional diagnostic and treatment options located nearby in Coeur d'Alene, patients can remain close to home for all their care.

Plastic and Reconstructive Surgery (208) 625-4333

Kootenai Clinic welcomed plastic surgeon Benjamin Mandel, M.D. and opened its first plastic and reconstructive surgery practice. Plastic and Reconstructive Surgery serves an important role in a patient's health by restoring form and function. Whether a patient is receiving reconstruction after cancer or a trauma, or is undergoing an elective procedure to enhance natural beauty, plastic surgery can help patients feel more confident about their appearance.

Family Medicine Residency (208) 625-6000

In 2014, the inaugural class of six family medicine residents began the first of their three years of training at Kootenai. While they are here, the residents will be working shoulder-to-shoulder with experienced physicians and specialists. Their ability to work and learn right here in northern Idaho also increases the chance that they will stay and practice medicine here even after they graduate.

Pharmacy Practice Residency

In 2014 leaders from Kootenai Health's pharmacy departments came together to start the first pharmacy residency at Kootenai. The pharmacy practice residency gives experience in a broad area of pharmacy practice.

Vascular Surgery Clinic (208) 625-5222

In 2014 Kootenai Clinic opened a new clinic solely for

vascular surgery patients. Philip Kladar, M.D., and new vascular surgeon Christopher Ward, M.D., make up the vascular surgery team. Kootenai Clinic Vascular Surgery specializes in the treatment of arteries and veins.

GROWTH AND SERVICE LINE

Kootenai Health Expansion

In August 2014 Kootenai Health broke ground on a \$57 million, three-story expansion. The first two floors will include a family birth center, neonatal intensive care unit (NICU), more patient rooms, a new hospital entrance and registration area, and expanded visitor waiting areas. The third floor will remain unfinished during the initial phase of the project. Once the first two floors are completed and open, the expansion will give Kootenai about a 10 percent increase in patient rooms. By the end of 2014, the foundation and steel framing was completed. The expansion is expected to open in spring 2016.

Patient Transfers Triple

In 2012 Kootenai Health opened the Patient Transfer Center to help facilitate transfers between local and regional hospitals. In 2014, the transfer center facilitated 3,971 patient transfers, 1,463 direct admissions and 5,822 provider consultations. This is just one of many ways Kootenai is working to keep patients closer to home for health care.

Rehabilitation Hospital of the Northwest

The Rehabilitation Hospital of the Northwest, a joint venture between Ernest Health Inc. and Kootenai Health, began treating patients in December 2013. The new rehabilitation hospital provides intensive physical rehabilitation services to patients including those recovering from strokes, head and spinal cord injuries. Providing this higher level of care in our community is helping patients stay closer to their families while receiving care.

SUPERIOR QUALITY AND SAFETY

Kootenai joins the Mayo Clinic Care Network

Kootenai Health is now a member of the Mayo Clinic Care Network, a national network of like-minded organizations that share a commitment to better serving patients and their families. As part of the Mayo Clinic Care



Network, Kootenai Health physicians now have access to Mayo Clinic's knowledge and expertise

when these additional resources can be helpful, allowing many patients to avoid unnecessary travel for answers to complex medical questions. Like all network members, Kootenai Health remains a locally owned and independent health care provider.

Heart Failure Clinic (208) 625-5230

The Heart Failure Clinic was developed by Heart Clinics Northwest in August 2014. The goal of the clinic is to improve education and follow-up for heart failure patients to prevent readmission to the hospital. Although this program is currently for Heart Clinics Northwest patients, plans to expand it are underway.



Trauma Verification

The American College of Surgeons Committee on Trauma verified Kootenai Health as a Level III Trauma Center. To receive verification, Kootenai had to prove it has the resources needed to provide the entire spectrum of trauma care. Every year, thousands of injured patients seek care at Kootenai Health's emergency department. Trauma center verification offers important reassurance that patients are receiving excellent care.

Level II Nursery

Kootenai Health's special care nursery received a Level II-b

nursery designation in 2014. This designation means the nursery has the facilities and staff to care for babies born as early as 32 weeks gestation (eight weeks premature), and as small as 1,500 grams (3 pounds). Experienced, board-certified neonatologists care for these fragile newborns around the clock. Koote nai's eight-bed nursery is designed for babies requiring comprehensive care, monitoring and intensive medical attention.





Community Benefit - \$95.9 million

Community benefit activities are programs and services hospitals provide to help improve health and increase access to health care in their communities. During 2014, Kootenai Health provided approximately \$95.9 million in gualified community benefits to people in our region.*

This amount includes the following:

\$51.3 million **Government Insurance Programs**

Many people don't know that programs like Medicare, Medicaid and State or County insurance programs do not pay the full cost for the care their participants receive. In 2014, Kootenai Health absorbed \$51.3 million in costs that were not reimbursed by these payors. That included \$42.6 million for Medicare patients. \$5.6 million for Medicaid patients and \$3.1 million for state and county patients.


\$13.6 million Free and Discounted Care

Kootenai Health wrote off \$6.1 million worth of charges for patients who could not pay for their care. Another \$7.5 million was written off as part of a new discount program that reduces charges for uninsured patients by 25 percent.

Total Revenue has been steadily increasing over the past five years from \$269M in 2010 to an estimated \$408M in 2015.

Uncompensated Care (Bad Debt)

\$26.5 million worth of charges to patients who were unwilling to pay the "patient responsibility" of their health care bills were also written off.

Donations, Free Services, and Programs

Each year Kootenai Health makes substantial financial and in-kind donations that benefit our community. This includes donations to groups such as Hospice of North Idaho, and Komen for the Cure. It also includes the expense of providing free and low-cost health screenings and support groups for patients. In-kind donations also include expenses and staff time related to providing training opportunities for physicians, nurses and other health care workers. Together, these donations, free services and programs are improving how people are cared for in our community.

As Kootenai Health offers more services to care for the patients and families of northern Idaho, more people are coming to our hospital for care. More space is needed to take care for our patients and to make room for improvements in our existing facility. That's why we are building a new three-story addition.

Kootenai Health's \$57 million, three-story expansion is scheduled to open in the spring of 2016. The expansion will adjoin the east side of the existing hospital. Its first two floors will include a family birth center, neonatal intensive care unit (NICU), more patient rooms, a new hospital entrance and registration area, and expanded visitor waiting areas. The third floor will be staged for completion at a later date.

With thanks to our board, physicians, staff, and construction team, we are pleased to report that our expansion is on time and under budget. We would also like to thank **you** for your patience and understanding as we've modified our entrance, changed our parking areas and taken extra efforts to ensure all our patients receive the care they need.
